# EUDR DDS – Units of Measure Guidance for Economic Operators

This document provides guidance on the correct use of Units of Measure (UoM) when registering data in 'Box 6' during the DDS submission in the EUDR system. The rules differ depending on the selected Activity type in 'Box 2' and apply to both UI and API submissions.

# 1. DDS with Activity: Import or Export

#### Preconditions: Activity selected = Import <u>OR</u> Export



## **Mandatory Fields**

- Net Mass (Kg): Always required for Import / Export activity.

# **Supplementary Unit Type**

- Read-only and automatically preselected if applicable for the HS code.
- Please see the Commodity Code Dependent Supplementary Unit List in Appendix I of this document. The same supplementary units are also applicable for sub-codes of the Commodity Codes listed in Appendix I (example: the supplementary unit for HS Code 4011 also applies to HS Code 4011 10)
- Please note that HS code matching is performed on the first 4 HS code digits (except for the 6-digit HS codes in the list where an exact match is required)

#### - Examples:

HS Code selected	Supplementary code applied
47	N/A
4701	KSD (kg 90% sdt)
4410	MTQ (m <sup>3</sup> )
441011	MTQ (m <sup>3</sup> )
010221	NAR (p/st)

**Important note:** The extension of applicability of supplementary units to the 6-digit sub-headings will be enabled in the next release. Currently in EUDR (release 7.3.1) the rule applies to the 4-digit codes, except for 010221 and 010229 where there is corresponding no 4-digit code.

# **Supplementary Units**

- Mandatory only if the commodity code appears in Appendix I of this document.
- If not applicable, no supplementary unit type or value is allowed, see Annex II point 2,  $3^{\rm rd}$  sentence of the EUDR.

# 2. DDS with Activity: Domestic or Trade

# Preconditions: Activity selected = Domestic OR Trade



## **Valid Units of Measure Combinations**

#### 1. Net Mass and Percentage estimate or deviation

- Allowed values for Percentage estimate or deviation: 0 – 25.

## 2. Supplementary unit type and quantity

- Code list available in Annex Appendix II of this document.
- Display Text from Annex Appendix II of this document appears in the 'Type' field.
- Display on Hover text appears in the dropdown list.

#### 3. Net Mass with Percentage estimate or deviation AND supplementary unit type and quantity

- Same rules apply as above for Supplementary Unit Type and value, and for the Percentage estimate or deviation.
