# **Teaching Public Administration**

#### Themes for Presentation and Discussion

Participants of this Study Group are invited to present theoretical contributions as well as empirical findings in the field of – or of importance for – PA/PM/PG education and training, practical experiences and case studies, as well as the assessment of observed results and impacts.

We welcome all contributions that relate to teaching public administration. Particular attention will be given to contributions evolving around the following themes:

- ✓ Teaching Public Administration and Management for the Sustainable Development Goals
  How do the SDGs best fit within the PA curriculum? What are the best approaches for teaching the SDGs in PA programmes? Are there any particularly useful case studies that can be used to teach SDGs in PA programmes? How best can we integrate the particular SDGs, such as Decent Work and Economic Growth, into PA programmes?
- ✓ Critical perspectives on Teaching Public Administration and Management
  Many public managers receive generic management training and education. This education is often based
  on a universal view of organisations that cuts across public / private / third sector distinctions and fails to
  recognise the influence of national culture, norms or customs on public service delivery. Are there key public
  administration concepts (such as public value) that could enhance or even transform general management
  education to be more in line with what students, the economy and society needs?
- ✓ Challenges of poly-crises storms for Teaching Public Administration and Management
  The experience of COVID-19 created many challenges for both the student and the teacher experience.
  But how do we prepare ourselves and our students for future poly-crises? What are the most appropriate pedagogical techniques for equipping students with the skills required to respond to crises? Are there case studies that can be used in the classroom to demonstrate approaches to dealing with crises? What core concepts or theories should be embedded in public administration and management courses to reflect growing global uncertainties? And how will these experiences change the academic teaching of the future?

Participants are invited to join the Study Group by contributing to one of the following formats:

- (a) Regular PSG IX Paper Sessions
- (b) Panel / Round of Discussions
  Contributions to the group debates may include oral presentation of experiences and proposals for future strategies, new academic programs, teaching concepts or new experiments with teaching methods as well as proposals for mini- workshops or round tables or demonstrations of teaching instruments.

Please submit a short abstract of the proposed paper or a Round of Discussions proposal outlining its format, topic and content via the central electronic conference system (maximum 1 page).
