#### 1. OBJECTVES

080 Barcelona Fashion and Seed&Click are organizing 080 Investor Day's 5th edition with the objective to detect new talent in the fashion industry. With this in mind, they start the '080 Investor Day Raising Brands' initiative, seeking to award emerging fashion brands born in Catalonia recently.

The main objective of this event is to support and boost entrepreneurial initiatives, as well as to raise awareness on the emerging talents of the sector, helping them to get funding.

### 2. INVESTMENT FORUM

Are eligible: Emerging fashion brands based in Catalonia and developed by designers and/or entrepreneurs (+18 y/o), regardless of their nationalities. Their leaders must be currently working on a fashion business firm that should have a maximum billing of 50.000€ or a maximum of 4 collections developed.

The language of the event will be English.

#### 3. PARTICIPANTS

The projects can be presented individually or in teams. Teams that are selected as finalists will have to nominate a team representative that will present their idea or project on the day of the Grand Final.

## 4. SCOPE: BUSINESS AREAS

All the brands and designers must design, produce and commercialize fashion products that can (or not) include aspects regarding the following areas:

- Sustainability
- Design





- Technology
- Big Data
- Wearables
- Intelligent materials

#### 5. PHASES

## 5.1. Project presentation

The projects will apply to the Investment Forum by providing the required information at <a href="http://bit.ly/1dM0ULW">http://bit.ly/1dM0ULW</a>, selecting '080 Investor Day Raising Brands 2019' on the question 'Do you want to present your Project to any of the following Events?', on the section "Additional questions".

The projects should be submitted and presented in English.

#### 5.2. Selection

A panel of experts will analyze all the projects presented and will select a maximum of 5 finalists.

These brands selected as finalists will be announced as from the 3/06/2019, and will go through to the Grand Final.

#### 5.3. Grand Final

All the finalists will present their projects in *elevator pitch* format, with a maximum duration of 5 minutes on the day of the Grand Final **in June the 27th 2019** in front of the members of the jury, investors and the rest of the participants. After the presentation, the jury will deliberate behind closed doors in order to choose the winner. Once the jury has decided, the prize will be given.

The term *elevator pitch* refers to the presentation of a project in a limited time, focusing on the most relevant and interesting points for the audience we are aiming at.

## **6. INFORMATION TO BE PRESENTED**

All participants must present the following information:

- Name and description of the business project





- Name and experience of the team members
- Market situation: problems and possible solutions
- Business Model or Commercialization Plan
- Competition
- Competitive advantage
- Financial projection
- Need and use of funds, possible exit of the investor
- Pictures of the fashion products of the brand and Video (not compulsory)

## 7. SELECTION CRITERIA

- Capacity of innovation and transformation: to what extent the project impacts current business, production, management and sales models.
- Viability: business plan, economic viability, job creation, track record, internationalization, etc.
- Capability of the project's managing team: experience and attitude.
- Potential for viral communication: originality and persuasive potential of the video presented, mobilization of social networks and positive impact of the business.
